Hello family. I attended the Regional meeting on March, 21. Our Regional Delegate reported that the World Convention is being scheduled to be in Melbourne, Australia in 2022. World expenses were currently at five million dollars and they only had 1.2 million. KRCNA 34 is scheduled to be the weekend of August 27, 28, 29 in Clarksville IN at the Derby Hotel. KRCNA 35 is hoping to be on schedule and fall on Easter weekend of 2022. There were questions about the intent of motion 1-1-21 at the last Area meeting. I contacted Tony, our Regional Chair and asked for more information. He explained that he did not believe the motion was not in writing. He didn't recollect the motion having to do with covid. The region periodically donates five thousand dollars to World Services. The Louisville Area normally donates one thousand quarterly and one hundred monthly to Region, however they have not been able to. The donation of 1,500 dollars is what is reasonable at the time and donating it is to keep our Regional bank account down.
