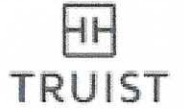

Report to Area

Dear Family,

Just opened up policy this morning so I could be honest and say that I actually did some work before our meeting so my report wouldn't be a total blank again.

That being said, reviewing our budget, (p 37 SCKANA P&P) there are several changes to be made and or discussed with a motion possibly put forward in the immediate future.

1). Adjusting our monthly Combined Communications bill from \$19.50 to \$21.50. There has been discussion of getting on a statewide phone line and possibly discontinuing this service. More will be revealed.

2). Rent. Currently in policy \$120/yr. Paid \$30/quarter. Since the pandemic all of our meetings were Zoom until in person/hybrid Zoom Area meetings resumed in August 2021. Do we need to pay rent to Christ Episcopal Church for our Area meeting? Or is the meeting space a donation from Living the Program? Either way, our 7th tradition needs to be upheld and I can't find any mention of that in our minutes or group reports from 2021/2022. A motion may be in order

3). I will consult with our treasurer and secretary to assure that the website fees are current and correct. Website hosting \$131.40 (\$282.80 paid every 2 years), domain name \$24.95 yearly?, and malware protection \$49.92/yr.

4). P.O. Box \$134/ yr will be removed as per motion 07-22-01.
