**The regional meeting will be March 17<sup>th</sup> in Louisville but I don't have the address for the physical location at this time. Our regional balance as of 2/29/24 is \$22,549.31 as of the treasurer's report I received today. The check #1263 was received, submitted to CEC, cashed and recorded as payment for the January regional meeting space held in BG.**

As a reminder:

The H&I Basics survey is online at [na.org](http://na.org)> for members> projects and surveys> H & I Basics. The deadline for input is March 31st 2024.

(Motion 9-3-23) ATRA asking for Billboard in their area – intent carry message. Seconded by SCKANA, came back for vote in January. Pros – get info out for help line and increase revenue. And if we send 10,000 to world why not give 2,000 to support Area. Cons – Regional funds for Area and the cost for 12 weeks.

- **Motion was tabled until March** so ATRANA can send out a photo of what the billboard will say.

(Motion 9-4-23) OVANA requesting \$735 for business cards and literature that would be used to further carry the message. (Literature 3rd World (?) \$200, Business Cards \$70, Holder \$60, IPS \$100, Books \$250) Cons – why not go to area for funds, will take fundraising to sustain this project. Pro - region does not need 30,000 in account.

- **motion to table this until March** region because some areas did not see the motion. The full motion was not sent out with the minutes. OVANA will send out the full motion with these minutes. Answer question about where the money will go now that there is a metro PR (is this just for the meeting schedules or for all PR work? Where would the money go? To OVANA or to the pooled PR?)
